	(NOTE: This is an estimated time of arrival due to traffic patterns. Parents/Guardians will need		
	to arrive at Hillside's parking lot 30 minutes before the group is slated to return to ensure prompt		
	pick-up of students upon return.)		

Only ten (10) tickets are available. All permission slips must be returned to Hillside PC office no later than March 11, **2018.** The \$5 fee is for student participants, only. Scholarships may be available, on a first come, first served basis, if requests are received no later than March 4, 2018. If parents choose to include older siblings, the full price will be assessed (\$10 child or adult) and parents/guardians must provide transportation.

The student/chaperone ratio will be 1/5. All chaperones must have certificates on file indicating completion of a background check and the online Child Safety program, as required in the PC-USA 2016 Book of Order. Please note, if parents/guardians travel in the van with the group, they must have certificates on file. Parents/Guardians may choose to transport their child and meet the group at the venue.

Parents/Guardians are expected to be at Hillside when the van returns at approximately 1:00 pm. Be advised, the return time is an estimated arrival time, but pick-up is still expected to occur within five-minutes of arrival. Students who are not pickedup within five-minutes after the van returns will not be extended an invitation to attend the next trip planned in 2018.

If your K-5 child plans to attend this field trip, complete the attached forms—permission slip and student information form with \$5, cash attached and return to the Hillside PC office by March 11, 2018. No permission slips or health information slips will be accepted after the March 11, 2018, due date.

The CEM looks forward to sharing this experience with our youth.
